The majority of projects were in the energy and recycling sector (43%), followed by building/construction (18%) and IT services (14%). The latter sector created the most employment, with 38% of all Irish jobs recorded. Also of note was that Ireland was the second country, after Germany, to create or maintain the most jobs in the building/ construction sector, with 16% of all jobs announced in this sector.

lle de France (Paris region) hosted the most Irish projects, with 21% of the total, ahead of Centre-Val de Loire and Nouvelle Aquitaine (14% each).


