



# Italy

There were 117 new Italian investment projects recorded in France in 2024, including 113 that created or maintained 2,735 jobs. It was the best year in terms of jobs created or maintained by the investment decisions of Italian businesses, which increased 5% compared with 2023.

ATR: The world number one in regional aviation, owned equally by Airbus and Leonardo, and whose two turboprop models with up to 78 seats are to date the regional aircraft that emit the least carbon dioxide on the market, has launched a recruitment plan for 150 qualified fulltime workers, including 90 jobs created in 2024. These positions aim to enable the aircraft manufacturer to continue the study of its hybrid electric aircraft concept, the ATR EVO, for entry into service after 2030.

Iveco Group: The group has invested €112 million in France to increase production capacity for electric and hydrogen buses at the Annonay (Auvergne-Rhône-Alpes) and Rorthais (Nouvelle Aquitaine) factories, to improve the efficiency of the value chain and meet the growing demand for sustainable mobility in France and Europe. The investments also relate to the Bourbon-Lancy factory (Bourgogne-Franche-Comté), where the new XCursor 13 multi-fuel engine was designed and is produced. Many new jobs have been created in France for the new bus and battery assembly lines in Annonay, where recruitment is still

### They chose France in 2024

Allied: This Italian industrial group is among the global leaders in the production and distribution of fittings and pipes for the petrochemical, oil, gas and energy sectors. In 2024, the group launched an €11 million investment plan in France to expand two production facilities located in the Hauts de France region, Interfit in Maubeuge and BSL Pipes & Fittings in Billy-sur-Aisne. This investment will increase the group's production capacity, develop skills and products for more demanding markets, such as nuclear energy, while consolidating its position in the European market and contributing to local economic development.

The FDI stock¹ of businesses from Italy in France is around €54.5 billion, making Italy the seventh country with the largest FDI stock in France.

In 2024, a total of 117 new investment projects from Italy were recorded in France, 7% of all investments, including 113 that created or maintained 2,735 jobs, 7% of the total.

Jobs were on the rise again this year, after declining in 2023. This 5% growth enabled Italy to reach its record for jobs created or maintained since records began in 2014. In 2024, Italy was the fifth country to confirm the most investment in France and the third in the European

The majority of projects (40%) and jobs (69%) were linked to production/

manufacturing activities. Italy was also the second country to create the most jobs in this field, with 14% of all jobs created in production/ manufacturing. Italian projects also targeted decision-making centers (22%) and retail outlets (20%).

Sector-wise. Italian projects were mainly intended for the metalworking (15%), wholesale and retail (11%) and automotive industry (10%). It should be noted that in this last sector, Italy was the second country with the greatest number of confirmed investment projects, and the first in terms of employment generated, with 29% of all jobs generated in this sector in 2024.

lle de France (Paris region) hosted the most Italian projects (37%), ahead of Auvergne-Rhône-Alpes (15%) and Provence-Alpes-Côte d'Azur (9%), which profited from their bordering geographical locations.


